HERE IS ALL YOU NEED TO BRING:

- All W-2s and 1099s, and 1098Ts (if any)
- Copy of 2020 tax return
- A copy of your check for direct deposit of refund
- Valid picture identification for taxpayer and spouse – Driver's License or Passport
- Form 1095A, – Affordable Care Act Marketplace Documentation
- Social Security Cards or Individual Taxpayer Identification Numbers for all family members
- If college education credit, college statement of account for tuition paid.
- If joint return, both spouses must be present to sign return
- Letters regarding advance child credit and / or 2021 stimulus payments received.

TAP does **not** prepare income tax returns for taxpayers who have:

- ◆ Incomes over \$58,000
- ◆ Rental Property
- ◆ Itemized Deductions
